General Duties/Description:

The Population Health Initiative has an outstanding opportunity for a graduate research assistant to join our team for the Spring 2022 quarter to support an ongoing research project that aims to better understand community health and well-being. The graduate research assistant would primarily be involved with evaluating a community data dashboard and assisting a workgroup to research social and emotional health data. Key tasks and responsibilities for this position include:

- Conducting research on the measurement and assessment of social and emotional health (50%)
- Working collaboratively and independently to recruit for an evaluation survey and facilitate key informant interviews (30%)
- Assisting with data transcription, coding, and thematic analysis (10%)
- Developing written reports to summarize key research findings (10%)

Qualifications:

Candidates should have the following qualifications:

- Experience conducting literature reviews and writing research papers.
- Experience with conducting surveys, interviews, and/or focus groups.
- Experience with qualitative data analysis.
- Experience working with marginalized communities to improve health and well-being using principles of community-based participatory research.
- Detail- and deadline- oriented
- Ability to work remotely and independently.
