We are seeking applications for a postdoctoral position on a project, funded by the Canadian Institute of Health Research.

The successful candidate will work with an international research team studying the long-term impacts of exposure to wartime trauma and later life health outcomes, with a focus on epigenetics and biological outcomes. Data for the study comes from the Vietnam Health and Aging Study. See: VHAS - The University of Utah, for details.

This position will be under the direction of Dr. Zachary Zimmer at Mount Saint Vincent University (MSVU) in Halifax, Canada, but the successful candidate will be working with a global team of scientists. The successful candidate may locate geographically out of the Global Aging and Community Initiative at Mount Saint Vincent university (see Global Aging & Community Initiative (globalagingandcommunity.com), or arrangements can be made for remote working. We are interested in recent or soon to be doctoral graduates with strong quantitative

skills looking to enhance their scholarship through publication. While they will work together with an international research team, the successful candidate must also be able to work independently and creatively. Experience conducting research in the areas of DNA methylation and/or epigenetics of health and aging is preferred.

Applicants can be from any discipline but must be familiar with either demographic and/or sociological concepts, literature, and techniques. Proficiency in English is required.

The salary range for this position is approximately \$60,000 CAD/year. Start date is negotiable. The position runs for one year with a second-year renewal upon adequate progress.

Review of applications will begin May 1, 2022 and will continue to be accepted until the position is filled. This position is subject to final budgetary approval.
