#### Innovative Data for Social Research

The UW Data Collaborative (UWDC) provides the infrastructure to harness innovative, but hard-toaccess and highly sensitive data for the development of novel, high-quality research and evidencedriven policy making. Central to the UWDC is a state-of-the art computing cluster that provides access to sensitive and/or restricted data in a secure and computationally sophisticated environment.

## Secure Systems

#### Security features

- Data set usage restricted to named researchers
- End-to-end encryption with Husky OnNet VPN
- Secure authentication with DUO Mobile twofactor authentication
- Restricted network access
- Individual screening of research results to avoid disclosure of sensitive information


#### Security standards

#### **Data Hosting**

If you have data sets that contain protected health information (PHI) or personally identifiable information (PII), we can host your data and provide Windows Remote Desktop access 24/7.



## Hosted Data Sets

We currently host a number of data sets, some of which are available for general UW access with data use agreements, including:

### Northwest Federal Statistical Research Data Center

A partnership between the U.S. Census Bureau and the University of Washington, the NWFSRDC serves as a secured access-point for qualified researchers with approved projects to conduct research using non-public data from partnering government agencies and entities across the U.S. federal statistical system. The NWFSRDC is part of a network of 33 open Federal Statistical Research Data Centers (FSRDCs) but the only one in the Pacific Northwest of the United States.

## Better Suited, More Accurate & Accessible Data

Through the NWFSRDC, researchers may access restricted microdata that contain variables not available in public versions of datasets, detailed versions of variables, sensitive variables, full counts and/or larger samples, original responses, more detailed geography, less censoring, and previously linked data. Researchers may also have the opportunity, if approved, to enhance the reach of their research by linking data.

#### Supported Fields of Research

Business, Trade, Finance, and Management • Crime and Crime Victimization • Demography and Population Studies • Economics, Labor Markets, Entrepreneurship, Employment and Industry • Education and Education Policy • Hazard Reduction, Environmental Impact Assessment, Pollution Abatement • Health and Wellbeing, Health Insurance, and Health Policy • Housing, Housing Markets, and Residential Patterns • among others

#### Accessing the NWFSRDC

A standard, multiple-step process is required to conduct research at any FSRDC, including the NWFSRDC. This process requires time but is simple if you work closely from the beginning with the Executive Director and with the Administrator of the NWFSRDC. Both will help you navigate the process and answer your questions.

There may be fees associated with your use of the NWFSRDC, but if you are a UW faculty or staff (whose appointment is over 50% of time at UW) or a UW student, your fees are covered. Partnering agencies may charge fees to access their data, regardless of your status at UW. Foreign nationals are allowed to work with U.S. restricted-use data at any FSRDC, but must have lived in the United States for at least 3 of the last 5 years.

#### Access Process at a Glimpse:

- 1. Discuss your research idea or project with the Executive Director of the NWFSRDC and familiarize yourself with the FSRDC Research Proposal Guidelines.
- Work with the NWFSRDC Administrator to develop your application package: a research proposal (with sections for project description, requested data, research questions, timeline, empirical methods, and expected research outputs/disclosure risk, among others) and a statement of benefits to the US Census Bureau and the federal statistical system.
- 3. Submit your application through the Standard Application Process portal after approval from the Executive Director and Administrator.
- 4. Apply for Special Sworn Status (SSS) after your project has been approved.
- 5. Once your project is approved and SSS granted, conduct your analysis in the secured computing environment of the NWFSRDC on the UW Seattle Campus.
